## **Niko Clarifies Article in Indian Press**

The sale is subject to various approvals including from the Government of India and Niko's joint operating partner in the Hazira Field, Gujarat State Petroleum Corporation Limited.

Niko does not consider the operations from Hazira Field to be material as Hazira Field was nearing the end of its life and an abandonment program was being planned for the near future.
